To obtain an absentee ballot, provide all of the information requested below, sign the request, and mail, fax, e-mail or scan to the Colorado River Indian Tribes, Enrollment Department, 26600 Mohave Road, Parker, Arizona 85344. **This Absentee Ballot Request Form must be completed and signed only by the Tribal Member making the request! No other person may request or receive an Absentee Ballot on your behalf.** Instructions for casting the absentee ballot will accompany the ballot and your signature will be required next to your name on the signature page provided. Your signature must be returned with your ballot or your ballot will be disqualified.

Due to the short timeline set for this election set by the Constitution of the Colorado River Indian Tribes, all requests for absentee ballots must be received by the Enrollment Department no later than **Friday, April 13, 2018 by 5:00 p.m.** to help ensure sufficient time to return their absentee ballots to the Enrollment Department on/or before **April 28, 2018 at 6:00 p.m.**

ARTICLE 2
ELECTIONS
CHAPTER 4. ELIGIBILITY

*Section 2-401 (e): Tribal members who are residents of the Reservation and will be unable, for any reason, to be at the polls to vote on the day of the election and are otherwise eligible may vote in any election by absentee ballot, provided that they apply to the Election Board (through the Enrollment Department) at least three weeks before the election if requesting to receive the absentee ballot by mail. Nonresident tribal members may vote in Tribal elections by voting at the polls or by absentee ballot as provided above. Any Tribal member may vote by absentee ballot by appearing at the enrollment office prior to the day of the election.
