Shut-In Voting Information

On Election Day an Election Worker and the Enrollment Secretary will be accompanied by a Tribal Police Officer to visit the residence of those who are considered "Shut-In's" between the hours of 6:00 a.m. to 6:00 p.m.

Those individuals with a physical disability and/ or incapacity or confinement due to illness or may have a difficult time getting to the polling places may have their name placed on the Shut-In List. To ensure your name has been placed on the Shut-In list contact the Enrollment Department at 669-1240, 1241 or 1304.

Absentee Voting

Tribal members who are residents of the Reservation and will be unable, for any reason, to be at the polls to vote on the day of the election and are otherwise eligible to vote in any election by absentee ballot, provided that they apply to the Election Board (through the Enrollment Department) at least three weeks before the election if requesting to receive by absentee ballot by mail. Absentee Ballot Request forms are available on February 21, 2018 during office hours from 8:00 p.m. to 5:00 p.m.

Absentee Ballot Request forms must be requested in person. The individual can only request his or her Absentee Ballot request form and no other person can receive or request a form on your behalf. All Absentee requests must be received no later than 5:00 p.m. on Friday, April 13, 2018.

Any Tribal member may vote by absentee ballot by appearing at the enrollment office prior to the day of the election. This will be available beginning on Monday, April 16, 2018 through Friday, April 27, 2018 during regular business hours of 8:00 a.m. to 5:00 p.m.

For those residing off the reservation an Absentee Ballot Request form will be mailed to you. To obtain an absentee ballot, complete the form, sign and date and mail, fax, e-mail or scan to the Colorado River Indian Tribes Enrollment Department, 26600 Mohave Road, Parker, Arizona 85344. All Absentee Ballot requests to vote by mail must be received no later than 5:00 p.m. on Friday, April 13, 2018.
