Job Summary:

This is a non-supervisory position. The position provides wildland fire suppression to the community at large both on the reservation and to residents of Parker/La Paz County. The applicant must have a desire to help and aid their community. Applicant must be able to communicate with the general public, peers and supervisors. Applicant must show initiative and desire to self-improve their skills pertaining to the job. Must be dependable and self-disciplined.

Duties & Functions:

1. Must perform fire suppression activities, to include but not limited to, regulate and apply water streams, hose lays, advanced lines and removal of fuels.
2. Must use hand tools, equipment and techniques to accomplish goals.
3. Occasionally respond to various locations within the State of Arizona and occasional out of State Assignments.
4. Compiles and completes written documents pertaining to medical, fire and incident reports.
5. Must perform daily maintenance/housekeeping to include station and surrounding grounds, equipment and vehicles.
