### **One CRIT Member Death, One Tribal Community Member Death and One Hundred Nineteen (119) New Positive Cases of Coronavirus for the Colorado River Indian Tribes**

**CRIT is deeply saddened to report the deaths of one (1) CRIT Member and one (1) CRIT Tribal Community member due to COVID-19. Our heartfelt condolences go out to the families and loved ones at this very difficult time.**

The Colorado River Indian Tribes has been notified of One Hundred Nineteen (119) new positive cases of coronavirus resulting from individuals who were tested at the Parker Indian Health Center. These individuals are residents of the Colorado River Indian Reservation. This brings the total to 1479 positive cases for the Colorado River Indian Tribes. To date, there have been twenty-two (22) Tribal community member COVID related deaths.

The Department of Health and Social Services will work in conjunction with Parker Indian Health Center to identify and notify any persons that these individuals may have had contact with recently. If you have any symptoms such as fever, shortness of breath, cough, sore throat, headache, myalgias (body aches), chills, repeating shaking with chills, and new loss of taste or smell please contact the Parker Indian Health Center or your primary physician.

**All residents on the CRIT reservation are reminded to follow the CRIT Resolution 556-21, Extension of Phase Two Measures to Mitigate the Spread of COVID-19 with "Safer at Home" Orders Effective from January 1, 2022 – January 31, 2022. Along with the Reservation wide face mask guidance Resolution No. 254-21, in order to protect themselves and their households. Everyone is also reminded to continue to limit contact with anyone who is not a member of your immediate household.**

**The CRIT Reservation Wide Face Mask Guidance mandates the wearing of face coverings by all persons on the Colorado River Indian Reservation, whether or not fully vaccinated, in any indoor location outside of one's home. Businesses located within the Colorado River Indian Reservation shall continue to ensure staff and customers use face coverings within their establishments.**

The best ways to protect yourself are to take certain precautions including:

- Wash your hands often with soap and water for at least 20 seconds. If soap and water are unavailable, use an alcohol-based hand sanitizer.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Wear a face mask when you must leave your home to conduct essential tasks.
- Avoid close contact with anyone outside of your immediate household.
- Stay home when you are sick.
- Clean and disinfect frequently touched objects and surfaces. Cover your cough or sneezes with a tissue and immediately discard the tissue in the trash.
